## TOWNSHIP OFFICIAL OMA/FOIA MANDATED TRAINING REMINDER!

Please note that if you are a NEW TOWNSHIP OFFICIAL being elected for the first time, you have one year (through May 15, 2018) to complete the FOIA training provided by the Office of the Illinois Attorney General. This training is required for all new first-time officials. If you completed the training in the past for another position, you are NOT required to take the training a second time.
