Summertime Responsibilities - Signs

HE SEASONS THIS YEAR seemed to go from winter to summer (cold to hot). Although there were a few "spring" days this year, they were few and far between. While driving throughout the state I noticed that IDOT highway projects are clearly underway, and counties, municipalities, and road districts have many road, highway, and street improvements being performed. As a driver, it's always good to see roadwork being done,

especially when the project is complete. With summer being in full force there are responsibilities for highway commissioners and employees to keep-in-mind.

Keep signs clear of brush

According to the Illinois Department of Transportation's *Signing of Road District and Township Highways* manual: "All traffic signs should be kept in proper position, clean, legible, and should have adequate reflectivity at all times. Damaged or deteriorated signs should be replaced without delay."

TOIRMA recommends that highway commissioners regularly inspect signs along their highways, and not only address any issues that may be present, but document the findings and action taken. Please remember the following:

- The highway commissioner is responsible for keeping signs in good order.
- If a highway commissioner, other township officials, or employees are aware of a sign obstruction, damaged sign, or missing sign, then the problem should be addressed as soon as possible (this means immediately). This includes initially observing the problem, or being notified of the problem by a resident or another local government official such as the county sheriff's office.
- If a highway commissioner should have been aware of a problem due to it being obvious or present for an extended period of time there may be liability.

Again, having a regular inspection process in-place and documentation will help address these issues.

Placement of Traffic Control Devices Requires County Engineer Approval

The proper placement of traffic control signs on road district and township highways is a key part of having a safe and orderly traffic flow. When consider-

ing the installation of traffic control devices and signs, it is critical that traffic conditions and other technical considerations be evaluated/studied first. This evaluation/report should be conducted by a qualified engineer.

When placing signs, townships/road districts are required to conform with the Manual on Uniform Traffic Control Devices (MUTCD) and the Illinois Department of Transportation's (IDOT) Manual on Uniform Traffic Control Devices and any supplement, and receive written approval of the county engineer or superintendent of highways prior to placement.

[625 ILCS 5/11-304] states:

"Local authorities in their respective maintenance jurisdiction shall place and maintain such traffic-control devices, including temporary stop signs placed as a substitute for missing or damaged permanent stop signs required by the State Manual, upon highways under their maintenance jurisdiction as are required to indicate and carry out the provisions of this Chapter, and local traffic ordinances or to regulate, warn, or guide traffic. All such traffic control devices shall conform to the State Manual and Specifications and shall be justified by traffic warrants stated in the Manual. Temporary stop signs shall be placed in a manner to provide adequate visibility and legibility, and shall be placed within duration recommendations in the State Manual, unless circumstances require longer placement. Placement of traffic-control devices on township or road district roads also shall be subject to the written approval of the county engineer or superintendent of highways."

[605 ILCS 5/6-201 & 201.16 state]:

"The highway commissioner of each road district shall ... subject to the written approval of the County Superintendent of Highways to place, erect, and maintain on township or road district roads, traffic-control devices and signs authorized by this Code or by "The Illinois Vehicle Code."

Please remember the following:

Highway commissioners contact your County Engineer prior to installing a traffic control device and sign (highway commissioners must have written

- approval before placing).
- Contact J.U.L.I.E, Illinois One-Call System at: 811 or (800) 8892-0123.
- Maintain the sign (ongoing responsibility).
