I would like to share with all of you something I recently learned attending a county association meeting in DeWitt County. I was unaware of the significance of the folds in the American Flag – specifically at a funeral. This is something we should all recognize.

WHY THE AMERICAN FLAG IS FOLDED 13 TIMES

Have you ever noticed on TV or at military funerals that the honor guards pay meticulous attention to correctly folding the American flag 13 times?

The **first** fold of our flag is a symbol of life.

The **second** fold is a symbol of our belief in eternal life.

The **third** fold is made in honor and remembrance of the veterans departing our ranks who gave a portion of their lives for the defense of our country to attain peace throughout the world.

The **fourth** fold represents our weaker nature, for as American citizens trusting in God, it is to Him we turn in times of peace as well as in time of war for His divine guidance.

The **fifth** fold is a tribute to our country, for in the words of Stephen Decatur, "Our Country, in dealing with other countries, may she always be right; but it is still our country, right or wrong."

The **sixth** fold is for where our hearts lie. It is with our heart that we pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with Liberty and Justice for all.

The **seventh** fold is a tribute to our Armed Forces, for it is through the Armed Forces that we protect our country and our flag against all her enemies, whether they be found within or without the boundaries of our republic.

The **eighth** fold is a tribute to the one who entered into the valley of the shadow of death, that we might see the light of day, and to honor mother, for whom it flies on Mother's Day.

The **ninth** fold is a tribute to womanhood; for it has been through their faith, their love, loyalty and devotion that the character of the men and women who have made this country great has been molded. The **tenth** fold is a tribute to the father, for he, too, has given his sons and daughters for the defense of our country since they were first born.

The **eleventh** fold, in the eyes of a Hebrew citizen represents the lower portion of the seal of King David and King Solomon, and glorifies in their eyes, the God of Abraham, Isaac, and Jacob. The **twelfth** fold, in the eyes of a Christian citizen, represents an emblem of eternity and glorifies, in their eyes, God the Father, the Son, and Holy Spirit.

When the flag is completely folded, the stars are uppermost reminding us of our nation's motto, "In God We Trust". After the flag is completely folded and tucked in, it takes on the appearance of a cocked hat, ever reminding us of the soldiers who served under General George Washington, and the sailors and marines who served under Captain John Paul Jones, who were followed by their comrades and shipmates in the Armed Forces of the United States, preserving for us the rights, privileges, and freedoms we enjoy today. There are some traditions and ways of doing things which have deep meaning.

Question of the Month:

Question: Several contacts this month were regarding the issue of an elected official's "pecuniary interest" in a contract with the township. Specifically, what if a highway commissioner has a contract with the road district regarding equipment rental or answering the question – Can a township official work for the township or road district (having a pecuniary interest in a contract)?

The Township Code (60 ILCS 1/86/45 states "...no township officer or employee shall be interested directly or indirectly in his or her own name in the name of any other person, association, trust, or corporation, in any contract for work, materials, profits of work or materials, or services to be furnished or performed for the township ..." This language is also provided in the Highway Code (605 ILCS 5/6-411.1).

State law provides that there are applicable standards that would provide a township the opportunity to have such an interest in a contract for materials, merchandise, property, services or labor. The official may not have more than a 7.5 percent share in ownership in the contracting entity; they must publically disclose the nature and extent of their interest before or during deliberations; must abstain from voting on the awarding of such contract; and if the contract exceeds \$1,000, it must be bid and let to the lowest bidder.

The Office of the Illinois Attorney General has also issued opinions stating that since a township trustee has certain duties related to the township road district, such as budgeting and auditing of warrants, this activity is not permitted. SO a township trustee may not be hired, even part-time for the road district.

On this issue, the question expands to include the question – Is a Highway Commissioner permitted to have a lease contract with the township road district?

Answer: Only under certain statutory outlined circumstances. In townships having a population of less than 15,000, and with the approval of the township board, a highway commissioner may have such a pecuniary lease or contract if the aggregate total of those contracts is less than \$2,000 in the same fiscal year. **Example**: A commissioner leasing a personally owned building to a township to shelter equipment.
