As issues evolve during the new year we will explore opportunities to issue additional general policy interpretations that assist with overall administration of township statutory responsibilities.

Township Cemeteries

SPEAKER: David Evans, Deputy Director of the Cemetery and Funeral Oversight division of the Illinois Department of Financial and Professional Regulation

Understanding the Illinois General Assembly Process

This program provides an understanding of the legislative and lobbying process in Illinois. Government 101 a return to the basics to understand lobbying. What do we need to know as we monitor the activity of the Illinois General Assembly? What important factors are there when advocating for Township issues?

Highway Commissioner 101 SPEAKER: John Redlingshafer, Attorney, Heyl Royster

A highway commissioner is asked to do a lot – maintain and plow roads, keep their equipment in repair, and carefully oversee a budget for their road system. However, there is much, much more that a highway commissioner is expected to know. This course will provide an overview of many of these additional obligations under the law, including the Prevailing Wage Act, the bidding process, trade-in of equipment, vacating roads, and right-of-way disputes.

Take Advantage of This Great Educational Tool

3. Ask Questions in Real-Time

Webinar attendees have the opportunity to ask trainers questions as the webinar is going on. This allows attendees to have a personalized experience with each webinar. Trainers also provide contact information at the end of their session for attendees to make contact following the webinar with any further questions.

4. CE Hours

Webinars count toward TOI Certification Hours. If you are looking for a quick way to earn professional development certification hours, look no further than TOI's webinars! Each webinar counts for 1 CE hour.

5. On-Demand and Convenient
