This bill amendment allowed for a referendum to abolish all township assessors on a countywide basis by a majority vote and turn all duties over to the County Assessor.

A few days before the bill was to be heard in committee, we "blasted" out a legislative alert via email to everyone, asking folks to contact Senators on the Local Government Committee and ask them to vote "no" on the amendment and bill. This assault was definitely a "call to arms" and township officials from all over the state responded admirably. When the vote was taken in committee, it was defeated on a 4-5 vote.

Afterwards, we once again "blasted" out an email informing everyone of the committee vote. Here is a sampling of some of the responses I got back:
