Legislative Update

As for **Legislation** affecting townships in 2022 and 2023, here is a list of some bills that TOI either supported, opposed or was neutral on that passed in 2022.

Updates are provided weekly during the scheduled legislative session of the Illinois General Assembly. As the 103rd Illinois General Assembly began on Wednesday, January 11th, 2023, we are in the process of establishing our legislative watch list. The deadlines for bill introductions are in February 2023. Check out website for legislative updates.

SB 3789- SEN. JULIE MORRISON (D-29TH)/ REP. JONATHAN CARROLL (D-57TH)

Decennial Committees on Local Government Efficiency Act. Within one year after the effective date of the Act and at least once every 10 years thereafter, each unit of local government that may levy any tax (except municipalities and counties) must form a committee to: study local efficiencies, create a report with recommendations regarding efficiencies, increased accountability, and consolidation. Provides that the duties of the committee include, but are not limited to, the study of the unit of local government's governing statutes, ordinances, rules, procedures, powers, jurisdiction, shared services, intergovernmental agreements, and interrelationships with other units of local government and the State. Provides that the committee shall collect data, research, analysis, and public input. Dissolves the committee after completion of its report. TOI worked with sponsors to address many of our concerns. TOI Was Neutral.

In the November-December Veto Session, Amendment 3 was added to SB3789, clarifying...

HB 4228-DECENNIAL STUDY TRAILER BILL

In a county with a population under 400,000, the township board and the highway commissioner may form a joint committee for the purpose of the Decennial Study. This joint committee shall include the Township Supervisor; Township Trustees; Highway Commissioner; at least two residents of the township appointed by the Township Supervisor with advice and consent from the township board; at least one resident of the township appointed by the Highway Commissioner. The joint committee shall be chaired by the Township Supervisor and will issue a joint report with two sections- one section

for the township and one section for the road district. TOI worked with sponsors to allow the formation of the joint commission **TOI was Neutral.**

HB 4251- TOWNSHIP BID THRESHOLD BILL

Provides that any purchase by a township for services, materials, equipment, or supplies in excess of \$30,000 (rather than \$20,000) shall be contracted in specified ways. Provides that contracts for construction work whose estimated cost will exceed \$30,000 (rather than \$20,000) for township waterworks and sewerage systems shall be let to the lowest responsible bidder. This would bring townships in line with counties and municipalities. **TOI Supports.**

PA-102-0265

States that beginning in the levy year of 2022, each taxing district that has an aggregate property tax levy of more than \$5,000,000 for the applicable levy year shall make a good faith effort to collect and electronically publish data from all vendors and subcontractors doing business with the taxing district as to: Whether the vendor or subcontractor is a minority-owned, women-owned, or veteran-owned business, as defined in the Business Enterprise for Minorities, Woman, and Persons with Disabilities Act. Whether the vendor or subcontractor holds any certifications for those categories or if they are self-certifying; if the vendor self-certifies, then the taxing district shall publish whether the vendor qualifies as a small business under the feral Small Business Administration standards. This is an exempt mandate and no reimbursement by the State is required for the implementation of any mandate created by this amendatory act.

PA-102-1092

Grant Accountability and Transparency Act Fix - Rep. Jay Hoffman (D-113th) Removes the Grant Accountability and Transparency Act requirements from awards, including capital appropriated funds, made by the Department of Transportation to units of local government for the purposes of transportation projects utilizing State and federal funds. Provides that the Act shall recognize that federal and federal pass-through awards from the Department of Transportation to units of local government are governed by and must comply with specified federal guidelines. **TOI Supports.**

We have a busy 2023 ahead. Here are some bills to watch come January and the 2023:

BID THRESHOLD TRAILER (BILL NUMBER PENDING)

Amends the Illinois Highway Code. In provisions concerning the performance of functions by the highway commissioner of a road district, provides that, except for professional services, when the cost of construction, materials, supplies, new machinery, or equipment exceeds \$30,000 (instead of \$20,000), the contract for such construction, materials, supplies, machinery or equipment shall be let to the lowest responsible bidder if specified conditions are met. Effective immediately. **TOI SUPPORTS**

PREVAILING WAGE BILL- REP. MICHAEL HALPIN (D-72ND)/ SEN. DAVID KOEHLER (D-46TH)

Provides that prevailing wage be paid on the construction or demolition of public works performed by an employee of a public body engaged in the construction or demolition of public works on behalf of another public

body. This bill would gut intergovernmental agreements and be an unfunded mandate on local governments that would result in an increase of property taxes. **TOI Strongly Opposes**.

STATE MINIMUM WAGE INCREASED JANUARY 1, 2023

Public Act 101-0001 went into effect on February 19, 2019. This new minimum wage law increases the minimum wage gradually until 2025. The next increase took effect on January 1, 2023

The state minimum wage increased on January 1, 2023 from \$12.00 to \$13.00

As per the Minimum Wage Law, the definition of "employer" includes any individual, partnership, association, corporation, limited liability company, business trust, governmental or quasi-governmental body, or any person or group of persons acting directly or indirectly in the interest of an employer in relation to an employee, for which one or more persons are gainfully employed on some day within a calendar year. An employer is subject to the [Minimum Wage Law] in a calendar year on and after the first day in such calendar year in which he employs one or more persons, and for the following calendar year.

Governmental bodies are not exempt from the Minimum Wage Law, but there are reduced wages for certain part-time employees under the age of 18, as well as tipped employees.

To the right are the current wages in effect, as well as the statutorily required increases up to January 1, 2025.

ILLINOIS STATE MINIMUM WAGE CHART

Effective Date	Regular Minimum Wage	Tipped	Minors Working < 650 hrs per year
1/1/22	\$12.00	\$7.20	\$9.25
1/1/23	\$13.00	\$7.80	\$10.50
1/1/24	\$14.00	\$8.40	\$12.00
1/1/25	\$15.00	\$9.00	\$13.00

HOW TO STAY IN COMPLIANCE WITH PA 101-0001

- New employees 18 years or older may be paid up to \$0.50 less per hour for the first 90 days of employment (training wage).
- Employees under 18 years of age who work less than 650 hours per calendar may be paid at the rates on the chart above but are not eligible for the "Training Wage" reduction.
- Beginning January 1,2020 if a worker under 18 years of age works more than 650 hours for the employer during any calendar year, they must be paid the regular (over 18) wage.
- Tipped employees may be paid 60% of the hourly minimum wage
- Certain employees must be paid overtime, at time, and one-half of the regular rate, after 40 hours of work in a workweek.

Township Perspective is Moving!

Township Perspective is moving! The first iteration of the magazine you know today was created in 1941 under the name of *The Illinois Supervisor and County Commissioner* and it shortly evolved to *The Illinois County and Township Official*. TOI purchased the rights to the magazine in 1971, and in 1999 the name changed to *Township Perspective*. Shortly after TOI purchased the magazine, its production moved from Springfield to Astoria (where TOI was originally based) and was published by K.K. Stevens Publishing. And they continued the publishing of the magazine until the December 2022 issue. Starting this year, 2023, the publishing has now moved to Effingham with Kingery Printing, Co. We are excited for this new stage of life for the magazine!

2023 Mileage Rates

Beginning on January 1, 2023, the standard mileage rates for the use of a car (also vans, pickups or panel trucks) will be 65.5 cents per mile driven for business use, up 3 cents from the midyear increase setting the rate for the second half of 2022.
