TOI membership a wise investment for your township

TOI MEMBERSHIP provides our members with significant benefits. Eighty-five of our 102 counties operate under the township form of government with 1,428 townships. TOI membership dues are based on valuation (EAV) obtained from each county clerk's office and on population figures provided by the U.S. Bureau of Census from the latest census.

As a TOI member, you become part of a large, state-wide organization that speaks on your behalf with your best interest as its primary focus. By speaking with one voice for township government, we are able to change things for the better for everyone.

The Township Officials of Illinois serves as an information clearinghouse to member townships and road districts, the media, state and federal elected officials and agencies, and the public at large. TOI serves as an advisory organization, NOT a law enforcement agency. We have no enforcement authority to "force" any township official to do anything. When established in 1907, TOI's principal function was lobbying on behalf of membership townships. Today, TOI's function is threefold:

- ✓ EDUCATION of township officials
- ✓ LOBBYING on behalf of Illinois townships and road districts
- ✓ PROMOTION of township government

TOI assists its members through letters, emails, phone calls, and office consultations. TOI also produces several educational publications. The *Township Perspective* magazine is published 11 times a year and mailed to all member officials, Illinois State legislators, the Illinois Congressional delegation, and many state and federal agencies and interested parties. *Township Perspective* is our biggest tool for getting information into the hands of our members.

TOI's fiscal year ends August 31, and while the 2016-2017 year has seen many good things happen, we have continued to see township government come under attack. During the current fiscal year, TOI has continued to take the lead in providing services and educational programs for its members. TOI's educational programs are doing a fantastic job of providing our members with the very best and up-to-date information available. November 12-14, 2017 will be TOI's 2017

Annual Educational Conference at the Crowne Plaza Hotel in Springfield. You won't want to miss this opportunity to come together with township officials from all over the state to better educate yourself and participate in "**Township Government - Boot Camp.**"

The TOI lobbying effort is led by our TOI Legislative Committee that works to promote pro-township legislation. The TOI Legislative Committee is comprised of members of the TOI Board of Directors and they help generate grassroots support for or in opposition to specific legislation, as well as informing the membership on legislation affecting township government. TOI holds an annual Topics Day to promote townships' involvement in the legislative process and promote our message at the State Capitol.

TOI's legislative efforts continue to go well. However, once again this year, township government has come under attack from some members of the General Assembly. This year alone, over two dozen pieces of legislation were introduced that are aimed at making it easier to consolidate or eliminate townships/road districts. Because of these challenges, it is more important than ever before that we continue to work together to inform our legislators of the many good services and programs that townships provide. We must show and promote a united front at all times to protect township government. If we are going to continue to succeed and flourish, we need total support of the state's nearly 11,000 township officials.


